St Clair County AFT members who wish to cancel payroll deductions to AFT **must notify AFT**, and submit a cancellation form to the St Clair County Payroll Dept. through Talent Ed by 4 pm, September 15th.

BANK DRAFT: If you pay your AFT dues through Bank Draft, Skip Step 1.

Step 1: Notify the St Clair County Payroll Department BY 4 pm, September 15th

- You **MUST** submit a cancellation form through Talent Ed. If you have any questions or need help with this step, please ask your school bookkeeper for assistance (per Kimberly Smith in the Payroll Department). No other form of notification will be accepted by payroll.
- You must also notify AFT as described in the next step.

Step 2: Notify AFT via Email BY 4 pm, September 15th

• We recommend that you send an e-mail to jcaft2143@gmail.com by 4pm, September 15th. Be sure to copy yourself on the e-mail so you will have a record of the notification and keep that copy of the e-mail.

Please note: It is best to e-mail AFT, and submit the form to St Clair through Talent Ed, as soon as you decide to cancel your AFT membership instead of waiting until the September 15th deadline, so that you will have time to receive confirmation from AFT.
