# AEA Generic: PAYROLL DEDUCTION and BANK DRAFT CANCELLATION INFORMATION

The following information is for use in all Alabama public school districts **except Baldwin County, Jefferson County** Schools (JEFCOED), and St Clair County Schools. These 3 systems have their own requirements.

- Baldwin County AEA members go to www.ACOE.us/AEA-Baldwin.
- Jefferson County (JEFCOED) AEA members go to www.ACOE.us/AEA-JEFCOED.
- St Clair County AEA members go to www.ACOE.us/AEA-St.Clair.

If you pay your AEA membership dues through payroll deduction, you must **notify AEA and** your **payroll department**, in writing, **by 4 pm on September 15th**. Additionally, AEA members who are paying A-Vote fees through monthly bank drafts must also instruct AEA to cancel those bank drafts.

### BANK DRAFT: If you pay your AEA dues through Bank Draft, Skip Step 1.

### Step 1: Notify Your District Payroll Department in writing, by 4 pm on September 15th.

Use the attached form. Send a completed copy of the form to your district payroll department and keep a copy for your records.

### Step 2: Notify AEA via Email by 4 pm on September 15th.

We recommend that you send an e-mail to myAEA@alaedu.org and Carbon Copy TeresaK@ALAEDU.org, and ShirleyW@ALAEDU.org by 4pm on September 15th and copy yourself on the e-mail to keep for your records.

**Please Note:** It is best to email AEA as soon as you decide to cancel your AEA membership instead of waiting until the September 15th deadline, so you will have time to receive confirmation from AEA. Be sure to **copy yourself** on the e-mail so you will have a record of the notification.
