**Step 1: Notify Your District Payroll Department by 4 pm on September 15th** Use the attached form. Send a completed copy of the form to your district payroll department and keep a copy for your records.

## Step 2: Notify AFT via Email by 4 pm on September 15th

- We recommend that you send an e-mail to ALL EMAIL ADDRESSES at the local office for the AFT district in which
  you are a member (see contact information below) by 4pm on September 15th. Be sure to copy yourself on the
  e-mail.
- **Please note**: It is best to e-mail AFT as soon as you decide to cancel your AFT membership instead of waiting until the September 15th deadline, so you will have time to receive confirmation from AFT.
